FORMER ANGLO-DANISH SOCIETY SCHOLAR PLAYS KEY ROLE IN AUTHENTICATING REMBRANDT SELF-PORTRAIT

You will be especially aware if you watched the fascinating BBC programmes “Fake or Fortune” that the attribution of paintings, which may change their value from thousands of pounds to millions or vice versa, can hang on slender threads. Historically these threads were the essentially subjective opinions of one or perhaps a group of experts whose particular authority was recognised by the art world.

This story, like those in the TV series, is about how modern technology is helping to make the process much

more objective. For many years a “Rembrandt” self-portrait, belonging to the National Trust, had been accepted and presented as genuine but then in 1968 the first doubts were sown by Rembrandt specialist Horst Gerson and the Rembrandt Research Group. However in 2005 van de Wetering, one of the experts in the Rembrandt Research Group, on seeing an X-radiograph and some other circumstantial evidence, began to think that Horst Gerson and his other fellow experts might have got it wrong. This opinion was reinforced by a visit to Buckland Abbey, where the painting was on display, in the year 2012.

The National Trust fortified by this

response decided to send the painting to the Hamilton Kerr Institute for an in depth examination. And this is where our former scholar Christine Slottved Kimbriel (nee Reelsbo) comes into the picture. We helped to support her initial time at the Hamilton Kerr Institute, a leading centre for painting conservation attached to the University of Cambridge. Since then she has become part of the permanent staff at the Institute and was charged with working on the analysis of the painting.

Both the national and specialised press covered the story and in their articles it was Christine who was quoted on behalf of the Institute. She described how the self-portrait went through a series of analyses including infra-red reflectography, raking light photography, x-radiography as well as

pigment and medium analysis. Cleaning also revealed the original colours and painting style beneath. What then helped to convince van de Wetering was the quality of painting revealed especially in Rembrandt's cloak. The scientific proof that the signature was contemporaneous with the painting and not added later, as the experts had previously thought, was the final element that has once again restored the painting's status as a genuine work by the master.

The National Trust will once again show it with pride and as they say "give us a great story to tell as we bring the mystery of its authorship to life for our visitors to enjoy".



Arne Jacobsen (1902–1971) and Britain

The Royal Institute of British Architects hosted a most successful evening on September 17th to pay tribute to the life and work of Denmark's most famous architect with special emphasis on his two landmark designs in Britain: The Danish Embassy in Sloane Street and the grade I listed St Catherine's College in Oxford.

The guest speakers of the evening included Jacobsen's grandson, Tobias

Jacobsen who told us about his awe of the Great Man and how, as a child, he lived in an Arne Jacobsen designed house which everybody thought looked like an “Ice Cream Parlour”; And how, only now, he had come to terms with this great heritage as a designer, a title AJ himself disliked.

H.E. Claus Grube, who lives and works in the Danish Embassy spoke about how it feels to reside in the first ever specially designed embassy building. I rather gathered that our Ambassador finds it an enjoyable experience.

Dr Rod Hackney, one of the Anglo-Danish Society’s very first scholarship awardees (1972) who had worked with Arne Jacobsen in Copenhagen from 1967 until his death in 1971 started by paying tribute to the A-DS which was represented on the evening by Margit Staehr, hon. scholarship secretary, and the writer. Rod kindly said that without the Society’s support he would never have gained a doctorate. Rod showed a number of drawings and pictures of the iconic buildings he had worked on together with Jacobsen.

Arne Jacobsen himself was of course much inspired by the Bauhaus Movement and especially by Mies van der Rohe; Stephen Hodder MBE,

President of RIBA, explained, during the concluding speech, how he had been influenced by Jacobsen during his career and especially when commissioned to design the extension to St Catherine’s College.



The talks were accompanied by illustrations, drawings, and photographs of Arne Jacobsen’s buildings, but also of his wonderful furniture, fabrics and cutlery which had been specially designed for the buildings, but which are today – probably – even more popular: The Egg, the Swan, the Ant and so on.

I should also mention the fascinating lecture given by Henrik Lund-Larsen, Partner of the Arne Jacobsen Society , who is currently writing a book ‘Iconic Design – evolutions of Arne Jacobsen’s design.

The evening concluded with a drinks reception. I am glad I came!
