By chance A-DS Member, Hafdis Bennett opened her stunning photographic exhibition in the Icelandic Embassy in 2a Hans Street that same evening and had kindly invited members for a preview and refreshments.

The AGM was totally overshadowed by the news that DFDS had just announced the termination of the passenger route Harwich/Esbjerg at the end of September. The route has existed for nearly 150 years, and all we Danes, resident in the UK, have not only been dependent on this route, but also had very happy memories (and sometimes not so happy ones) of travelling home and coming back to the UK on these

magnificent ships. It was a shock to everybody, and I am sure many more words will be written about this. After the official proceedings the Society's honorary president, Ambassador Claus Grube and Mrs Susanne Fournais Grube hosted a reception in their beautiful residence where we were joined by nine of our scholars, past and present. Anni Djurhuus and Jesper Eis Eriksen, two of our 2014/15 awardees, were presented to and congratulated by His Excellency and afterwards mingled with the guests.

The Viking World

Our day at the British Museum's Viking Exhibition in March started with elevenses in the Clore Education Centre Foyer before we went into the Stevenson Lecture Theatre along with members of other Anglo-Scandinavian Societies for a talk with slides by the Exhibition's curator, Dr Gareth Williams.



The museum's last Viking Exhibition was in 1980. Do we really need a new one? The answer is yes, not only because there is a whole new generation that has not seen a major exhibition on Vikings, but also because the old stereotypes of Vikings as pirates, raiders and marauders are not accurate. New finds and interpretations are subtly changing our views of the Vikings. They were in fact traders, settlers, craftsmen, poets, explorers, shipbuilders and sailors. The current exhibition which runs till 22nd June is a joint venture between museums in Copenhagen, London and Berlin. The glamour, romance and nastiness should capture modern imagination – exciting!



In this exhibition Scandinavia is seen as the centre of the Viking world which expanded westwards, eastwards and southwards. It is not well known that Vikings traded and raided both in Morocco and in Southern Spain. They went down through Russia into the Black Sea and eastwards as far as Afghanistan and Uzbekistan. Vikings also left traces in North America – ideas, fashion and art styles.

Ships made all this possible and the exhibition emphasizes the importance of the big boat. Roskilde 6 found underneath the soil in 1996 is 37 metres long. It is the largest ever found – now a symbol of the Viking Age – and has been specially mounted for the Exhibition. The space in the new Sainsbury Wing makes it possible to display the whole boat; there would not have been adequate space anywhere else. It was built around 1025, lost some twenty years later and discovered in 1996. Such ships crossed the open sea, but also penetrated inland along larger rivers in what is now Russia and Ukraine. Viking warriors were both male and female – the latter called “Valkyries”.

The Roskilde 6 ship – the ultimate display of sea power – had 39/40 oars. It was made in Norway and the



new steel frame now displaying its shape and length was designed to hold it all together in two containers for transport. In that vast exhibition room are also weapons and armour as well as various adornment of warriors plus helmets (no horns!)

The Vikings were traders who exchanged amber, ivory and silk both east and westwards. Slave trade also – they carried off thousands of people, selling them. One shouldn't romanticize the Viking Age! Building a ship was a massive investment and among Vikings display of wealth was important. The jewellery showed exquisite workmanship, weapons also decorative and ornate so that they could hack someone to pieces stylishly. (“I’ve got a pretty expensive axe!”) Showing off seemed part of their life style – wearing a 2.2 kilo gold neckring must have been quite tiring, but obviously worth it.

After the talk and questions answered, our chairman Christian Williams thanked Gareth Williams for

his ‘inspiring, spiced with humour lecture’, and we all dispersed for lunch. Forty of us were booked in the Great Court Restaurant where we enjoyed a delicious meal and had the opportunity to chat to members we had not met before. Then it was down to the Sainsbury Wing with our timed tickets.



the boat was truly astonishing – an overpowering image of the Vikings’ adventurous spirit. The last exhibits documented the Vikings’ change from belief in several gods to one God – Christianity.

The exit ran through to the shop which was a pleasant uncrowded area with lots of items to tempt you. I bought the big book about the Exhibition and look forward to studying it at leisure, reliving the experience of gazing at Roskilde 6 and also having the opportunity of looking again at all the marvellous jewellery and weaponry which I only fleetingly encountered on my walk through the first part of the Exhibition.
